# OUTCOMES OF THE MEETING

# 1 Signing of COOMET MoU by the representative of of Armenia About the entering of the Republic of Azerbaijan into COOMET About new COOMET Committee Members

The COOMET President informed the participants of the meeting about the request received from the Republic of Armenia and the Republic of Azerbaijan to join COOMET.

The COOMET Committee approved the National Institute of Metrology of the Republic of Armenia and the State Agency for Standardization, Metrology and Patents of the Republic of Azerbaijan as full members of COOMET.

The solemn ceremony of signing the COOMET Memorandum of Understanding by the representatives of the above mentioned institutes was held.

The COOMET President informed the participants of the meeting about the official information received concerning the appointment of new COOMET Committee Members from:

### 2 About the membership of Romania in COOMET

The COOMET Committee Members and the participants of the meeting discussed the question concerning further participation of Romania in the cooperation within COOMET, the country the representatives of which have not been taking part in the COOMET Committee meetings for a number of years, without any explanation of the reason.

It was also noted that Romania had participated in the foundation of COOMET (it was among the countries that signed the first Memorandum of Understanding), as well as that Romanian experts took part in some comparisons organized within COOMET.

Besides, the COOMET Committee Member Mr. H.-D. Velfe informed that he had had negotiations with Mr. D. Boiciuc, the representative of the National Metrology Institute of Romania, during which he expressed interest in the continuation of the work within COOMET.

The participants of the meeting expressed the opinion on the need to carry on additional negotiations on this question with not only the NMI of Romania but also with Romanian Bureau of Legal Metrology.

#### **RESOLUTION 7**

To continue the attempts to specify the position of the NMI of Romania concerning the membership in COOMET, with this end in view to apply to the NMI of Romania in written form once more and ask Dr. Katerin Katerinov, the COOMET Committee Member from Bulgaria, the Chairperson of Bulgarian Institute of Metrology, to discuss this question with the BIPM administration and the NMI of Romania and inform COOMET President and Secretariat on the results

The COOMET President also emphasized the main tasks concerning the COOMET activity for the near future.

# 5 Improvement and further development of COOMET cooperation

#### 5.1 Discussion of addenda to the COOMET Development Programme for 2005 – 2007

The COOMET President Dr. N. Zhagora submitted the draft addenda to the COOMET Development Programme for 2005-2007 approved by the COOMET President's Council which imply the study of the experience of international and regional organisations in supporting developing countries, as well as the capabilities of COOMET to carry out such activities; organisation of activities concerning long-term planning and realization of regional COOMET projects, holding of events directed towards the promotion of the COOMET activities at the national and international levels, as well as the improvement of the organizational structure of COOMET (in particular, the establishment of a subcommittee for the work with young metrologists of COOMET Member Countries within TC 4)

These suggestions were supported by the participants of the meeting.

### 6 COOMET activities in 2006 – 2007

### 6.1 Annual report of COOMET Secretariat

The participants of the meeting heard the report of the COOMET Secretariat on the activities for the period of 2006-2007 presented by the Head of the Secretariat Mrs. L. Astafijeva.

#### 6.2 Annual reports of Chairpersons of COOMET Structural Bodies

The participants of the meeting heard the annual reports of the Chairpersons of COOMET Structural Bodies on the activities for the period of 2006-2007.

The report of the Chairperson of the Joint Committee on Measurement Standards Dr. Sergey Korostin included the review of the activity of COOMET TC 1.1 - 1.12, as well as information on the results of the meeting of the Joint Committee held on 23 April, 2007 during which the heads of TC 1.2 - 1.12 presented detailed annual reports on the activity of the TCs.

The report of the Chairperson of the Joint Committee on Measurement Standards was supplemented by the Chairpersons of COOMET TCs (or their representatives) present at the meeting: Mrs. Valentina Pozdeeva, Chairperson of TC 1.2 "Acoustics, ultrasound, vibration"; Mrs. Tatiana Kolomiets, Chairperson of TC 1.3 "Electricity and magnetism"; Dr. Valeriy Kuznetsov, Chairperson of TC 1.7 "Photometry and radiometry"; Mrs. Anna Kolobova, representative of Chairperson of TC 1.8 "Physical chemistry"; Dr. Vitaliy Palchikov, Chairperson of TC 1.11 "Time and frequency"; Prof. Vladislav Leonov, Chairperson of TC 1.12 "Reference materials" who focused attention on the most important results of activities during the year from the 16<sup>th</sup> COOMET Committee Meeting and current problems in cooperation.

The Deputy Chairperson of TC 2 "Legal metrology" Dr. Hartmut Apel presented the annual report on the TC 2 activity and described in detail the projects carried out within this subject field, results of the last TC meeting (July 2006, Moldova) and outcomes of the training courses organized by TC 2 concerning the problems of software testing and prepackage control. Dr. H. Apel paid the attention of the participants of the meeting to the need in electing a new TC 2 Chairperson.

Dr. Stanislav Musil, Chairperson of TC 3 of COOMET Quality Forum, informed about the results of the activity of the Quality Forum in the area of evaluating Quality Management Systems of the NMIs of COOMET Member Countries realized for the purpose of implementing the requirements of the CIPM MRA. The problem of conducting external reviews of QMS of the NMIs of COOMET Member Countries which are considerably remote (e.g. Cuba) was discussed. The Executive Secretary of JCRB Dr. Pedro Espina informed about the possibility to involve the BIPM experts into external reviews of QMS of COOMET NMIs, as well as promised to investigate the possibilities to provide financial support for the review of the QMS of the NMI of Cuba. During the discussion the problems of the exclusion of the CMC published before though not supported by a QMS from the BIPM database.

The Chairperson of TC 4 "Information and training" Mrs. L. Astafijeva submitted the annual report on the COOMET activity in the area of information and training and results of the implementation of the Working Programme of TC 4 for 2005-2007.

The detailed information on each subject field is given in annual reports of COOMET Structural Bodies.

#### **RESOLUTION 13**

To take note of the Annual Reports prepared by the Chairpersons of COOMET Structural Bodies (Annex 17-05).

To ask BelGIM to organize the meeting of TC 1.6 "Mass and related quantities" in Minsk (Belarus) in September 2007.

To ask GP "NII "Systema" and NSC "Institute of Metrology" to organize the meeting of TC 2 "Legal metrology" in Lviv (Ukraine) in September 2007.

#### 7 Realization of the CIPM MRA

Within this item of the agenda the Chairperson of the Joint Committee on Measurement Standard Dr. Sergey Korostin, Chairperson of TC 3.1 of the Quality Forum Dr. Stanislav Musil and the Head of COOMET Secretariat of Ukraine Mr. Pavel Neyezhmakov addressed the meeting.

The participants of the meeting were informed about the results of the 17<sup>th</sup> JCRB Meeting, main results and problems of the NMIs of COOMET Member Countries concerning the implementation of the CIPM MRA, as well as about further tasks COOMET would face.

The reporters presented detailed information about the current state of preparation and review of COOMET CMC and carrying out of interregional review of CMC of other RMOs; information on the carrying out of external reviews of QMS in the NMIs of COOMET Member Countries (attention was paid to the necessity to carry out the reviews of all NMIs of COOMET Member Countries which are Signatories of the CIPM MRA as soon as possible); matters of preparation and carrying out of comparisons of measurement standards within COOMET were also discussed.

The following documents were submitted for the participants of the meeting:

- the updated Programme of Comparisons of Measurement Standards of COOMET NMIs;
- proposals for the drawing up of the Programme of Calibration of National Measurement Standards of NMIs of COOMET Member Countries;
- Draft Technical Protocol and Draft COOMET Comparison Report;
- revised template of a COOMET Calibration Certificate and rules for its completion.

The above listed documents were discussed in detail.

# 7.1 Discussion of the results of the 17<sup>th</sup> JCRB Meetings and COOMET tasks based on the decisions adopted at these meetings

- preparing and publishing reports on comparisons in KCDB in proper time;
- observing the terms of CMC review.

# 7.3 Current state of conducting the presentations of Quality Management Systems of QMS of COOMET NMIs and their peer reviews

#### **RESOLUTION 19**

To recommend to COOMET Quality Forum to accelerate the carrying out of peer reviews of the quality management systems of Ivano-Frankovsk CSM (Ukraine); INIMET, CENTIS-DMR, CPHR (Cuba); NISM (Moldova) and inspection control of VNIIR (Russia).

To recommend to the COOMET Committee Member from Kazakhstan to prepare a presentation of KazInMetr QMS for consideration at the meeting of COOMET Quality Forum at the beginning of 2008

To recommend to the NMIs of COOMET Member Countries, which plan to sign the CIPM MRA, to begin the work on preparing QMS presentations for their further submittal to COOMET Quality Forum.

#### **RESOLUTION 20**

To ask Dr. S. Musil, the Chairperson of TC 3.1 of the Quality Forum, to realize the updating of COOMET Recommendation R/AQ/13:2006 "Rules and Procedure for assessing Quality Management Systems of National Metrology Institutes of COOMET" (QSF 003) taking into consideration the requirements of the new JCRB documents and ISO Regulations and submit its updated version for approval at the next COOMET Committee Meeting.

#### **RESOLUTION 21**

To ask COOMET President, the Chairpersons of the Quality Forum and Quality Forum TC 3.1 to apply in written form to BIPM with the request to restore the CMCs of COOMET NMIs (UNIIM, SNIIM and GP "NII "Systema", Ukraine), which were deleted from it before.

# 7.4 About implementation of the Programme of Comparisons and Calibrations of Measurement Standards of NMIs of COOMET Member Countries

#### **RESOLUTION 22**

To take as the basis the presented version of the Programme of Comparisons of Measurement Standards of COOMET NMIs (as of 25 April, 2007).

To ask the Chairperson of the Joint Committee on Measurement Standards Dr. S. Korostin together with the Chairpersons of TC 1.1 - TC 1.11 to introduce addenda to the Programme (the deadline is 15 May, 2007) and to submit its updated version to COOMET Secretariat.

To ask COOMET President to sign the updated COOMET Programme of Comparisons of Measurement Standards of COOMET NMIs; to ask COOMET Secretariat to distribute the Programme (document COOMET D9/2007) among all COOMET Committee Members.

To ask the Chairperson of the Joint Committee on Measurement Standards together with the Chairpersons of TC 1.1 – TC 1.11 to brisk up the work of TCs on carrying out COOMET comparisons of national measurement standards and continue the work on further updating of the Programme with the annual submission of the updated version to the next meeting of COOMET Committee.

To ask COOMET Website Manager Dr. V. Bugaev and the Chairperson of COOMET Joint Committee on Measurement Standards Dr. S. Korostin to develop an automated database on COOMET comparisons and calibrations in 2007.

#### **RESOLUTION 23**

Results should be submitted for consideration at the next meeting of the President's Council and further approval at the 18<sup>th</sup> COOMET Committee Meeting.
