OUTCOMES OF THE MEETING

1 Implementation of the resolutions of the 17th COOMET Committee Meeting. Presentation of the Minutes

The Head of the COOMET Secretariat Dr P. Neyezhnikov presented the Minutes of the 17th COOMET Committee meeting and informed that the Secretariat had received no remarks with regard to the draft of these minutes.

2 COOMET President's report

The COOMET President Dr G. Sydorenko gave the report "COOMET Activity between the Committee Meetings and Tasks of Cooperation". The activity for the period of 2007–2008 was summed up in the report. The COOMET President also emphasized the main tasks with regard to the COOMET activity for the near future.

RESOLUTION 3

3 Improvement and further development of COOMET activities

The COOMET President presented the official information about the appointment of new COOMET Committee Member **from Kazakhstan**:

3.1 Discussion of the amendments to the Rules of Procedure of COOMET

COOMET President Dr G. Sydorenko presented the amendments to the COOMET Rules of Procedure to the participants of the meeting.

The Head of COOMET Secretariat Dr P. Neyezhnikov and Chairperson of JCMS Dr S. Korostin expressed their opinions on the necessity of proposed amendments with regard to the registration of COOMET projects on comparisons.

RESOLUTION 5

To charge COOMET Secretariat to make amendments in the Rules of Procedure, distribute them among the COOMET Committee Members and post the updated document on the COOMET Website (the deadline is 1 July, 2008).

The COOMET President Dr G. Sydorenko informed the participants of the meeting about the state of the implementation of COOMET Development Programme for 2005–2007.

3.3 Presentation of the COOMET Development Programme for 2008–2010

The COOMET President Dr G. Sydorenko presented the Draft COOMET Development Programme for 2008–2010 that had been approved by the COOMET President’s Council. Besides the traditional fields of activity the Programme includes such fields of activity as study of the experience of international and regional organisations in supporting developing countries, as well as COOMET capabilities to perform such activity; organisation of activity on advanced planning and realisation of regional COOMET Projects; holding of events aiming at COOMET promotion at the national and international levels, as well as improvement of the organizational structure of COOMET.

COOMET Vice-President S. Musil suggested excluding issues related to accreditation from the Programme.

These motions were supported by the participants of the meeting.

To approve the COOMET Development Programme for 2008–2010 (COOMET 18/04) taking into account the remarks and propositions expressed by the participants of the meeting.

To charge COOMET Secretariat to make editorial corrections in the COOMET Development Programme for 2008–2010, send it to COOMET Committee Members and post on the COOMET Website (the deadline is 1 July, 2008).

3.4 Approval of the distribution of responsibilities and authorities of the COOMET Vice-Presidents

The COOMET President Dr G. Sydorenko presented the revised list of the responsibilities of the COOMET President and Vice-Presidents approved at the 12th meeting of the COOMET President’s Council. The participants of the meeting exchanged their opinions on the submitted list and expressed their remarks and proposals.

RESOLUTION 8

4 Main results of COOMET activities in 2007–2008

4.1 Annual report of COOMET Secretariat

The Head of the COOMET Secretariat Dr P. Neyezhnikov submitted the annual report of the COOMET Secretariat about the activity carried out in 2007–2008.

RESOLUTION 9

To approve the annual report of COOMET Secretariat (COOMET 18/06).

4.2 Annual reports of the Chairpersons of the Structural Bodies

The participants of the meeting heard the report of the Chairperson of the COOMET Joint Committee on Measurement Standards Dr S. Korostin that included the review of the activities of COOMET TCs 1.1–1.12 in 2007–2008, as well as contained information about the results of the meeting of the Joint Committee held the day before, on 14 May, 2008, during which the Chairpersons of TC 1.1–TC 1.12 gave their detailed annual reports.

The report of the Chairperson of the COOMET Joint Committee on Measurement Standards was supplemented by the Chairpersons of the Technical Committees of COOMET (or their representatives) present at the meeting; they focused on the most important results of the activities since the 17th COOMET Committee meeting and current problems of cooperation.

Acting Chairperson of TC 2 “Legal Metrology” Dr O. Kühn presented the annual report of the activity of TC 2 informing about the projects being carried out in this area in detail, results of the last meeting of the TC (October 2007, Ukraine), and results of the training seminar “Software Testing for Measuring Instruments in COOMET Countries. General Approaches” held under the auspices of TC 2.

Dr S. Musil, Chairperson of TC 3.1 of the COOMET Quality Forum, informed about the results of the activity of the Quality Forum in the area of the reviews of QMS of COOMET NMIs conducted with

the view of implementing the requirements of the CIPM MRA. The problem of performing peer reviews of QMS of remote NMIs of COOMET was discussed. The participants of the meeting were informed about the change of the process of reviewing QMS of NMIs from two-stage to one-stage.

The Chairperson of TC 4 “Information and Training” Dr P. Neyezhnikov presented the annual report on the activity of COOMET in the area of information and training and the results of the implementation of activities of TC 4 in 2005–2007.

Such information on the activities in all subject fields is given in the annual reports of the structural bodies of COOMET.

RESOLUTION 10

To take note of the annual reports of the Chairpersons of the Structural Bodies of COOMET (COOMET 18/07).

5 Results of the 23rd General Conference on Weights and Measures and tasks of COOMET and NMIs resulting from its decisions

The participants of the meeting were informed about the results of the 23rd General Conference on Weights and Measures.

A discussion was held about the tasks of COOMET and NMIs resulting from the resolutions of the 23rd CGPM, in particular those concerning redefinition of the base SI units.

Mrs T. Kolomiets presented the materials of the 23rd CGPM translated by BELGIM into Russian to the COOMET President.

RESOLUTION 11

To take note of the information.

To ask COOMET Secretariat together with the National Secretariats of the Member Countries to prepare a summary on the results of the 23rd CGPM for the Governments of their countries, in which to pay attention to the economical effect of the metrological activity. Distribute this summary to the COOMET Committee Members for their governments to be informed (the deadline is 1 October, 2008).

6 Implementation of the CIPM MRA

Within this item of the agenda the Chairperson of the Joint Committee for Measurement Standards Dr S. Korostin, Chairperson of TC 3.1 of the Quality Forum Dr S. Musil, and Head of the COOMET Secretariat Dr P. Neyezhnikov reported.

The participants of the meeting were informed about the results of the 19th and 20th meetings of JCRB, main results and problems of the NMIs of COOMET Member Countries with regard to the realization of the CIPM MRA, as well as about further tasks COOMET will face. The participants of the meeting were informed about the on-going activity of JCRB with regard to the revision of the Guide to the Implementation of the CIPM MRA. The Chairperson of JCMS Dr S. Musil gave information about designated institutes in the light of the new requirements of JCRB.

The reporters gave detailed information about the state of preparation and review of COOMET CMC and carrying out of interregional review of the CMC of other RMO; information about the carrying out of peer reviews of QMS in the NMIs of COOMET Member Countries (the attention was drawn to the necessity of carrying out reviews in all NMIs of COOMET Member Countries that are signatories of the CIPM MRA as soon as possible); the organisation and carrying out of comparisons of national measurement standards within COOMET were discussed. The updated Programme of Comparisons of Measurement Standards of COOMET NMIs was presented to the participants of the meeting.

The Head of the COOMET Secretariat presented the results of the development of an electronic version of the COOMET calibration certificate, as well as the results of the discussion of the draft document “Rules for Implementing the Programme of Calibration of Measurement Standards of COOMET Member Countries” were discussed.

An enlarged discussion on the above mentioned issues was held.

6.1 Results of the 20th JCRB Meeting

RESOLUTION 12

To take note of the information on the results of the 19th and 20th JCRB Meeting.

6.2 About designated institutes in the light of the new requirements of JCRB

RESOLUTION 13

To take note of the information.

To ask the Chairperson of JCMS Dr S. Korostin to prepare a letter to the Executive Secretary of JCRB in order to explain the situation with designated institutes in COOMET and prepare an adapted form of the questionnaire by the 21st JCRB.

To ask COOMET Secretariat to distribute the questionnaire among all interested countries requesting to complete and send it to JCRB.

6.3 Current state of preparation and review of COOMET CMC

RESOLUTION 14

To recommend to the COOMET Committee Members and the NMIs of the Republic of Azerbaijan, the Republic of Armenia, the Republic of Georgia, the Republic of Kyrgyzstan, and the Republic of Uzbekistan to brisk up their work on the signing of the CIPM MRA, further participation in comparisons of national measurement standards and submittal of their CMC for intraregional and interregional reviews.

RESOLUTION 15

To draw the attention of the Chairpersons of Technical Committees and Coordinators of COOMET comparisons to the need to meet the deadlines for regional and interregional reviews of CMC.

6.4 Current state of carrying out presentations and external reviews of Quality Management Systems of COOMET NMIs

RESOLUTION 16

To recommend to the NMIs of COOMET Member Countries planning to sign the CIPM MRA to initiate their work on the preparation of the QMS presentations to be submitted for consideration of COOMET Quality Forum later on.

To ask COOMET Quality Forum to organize

- a peer review of the QMS of NISM (Moldova) in October 2008,
- an inspection review of the QMS of VNIIR (Russia) in November 2008,
- a peer review of the QMS of KazInMetr (Kazakhstan) in the first part of 2009.

6.5 Carrying out of the Programme of Comparison of Measurement Standards of COOMET NMIs

RESOLUTION 17

To take the submitted version of the Programme of Comparisons of Measurement Standards of the COOMET NMIs (as of 15 May, 2008) ([COOMET 18/08](#)) as the basis.

To ask the Chairperson of JCMS and the Chairpersons of TC 1.11–1.12 to prepare the final version of the COOMET Programme of Comparisons and send it to the Secretariat (the deadline is 1 July, 2008).

To ask COOMET President to sign the updated Programme of Comparisons of Measurement Standards of the COOMET NMIs. To charge COOMET Secretariat to send the Programme (document COOMET D9/2008) to all COOMET Committee Members and post it on the COOMET Website.

RESOLUTION 18

The Chairperson of JCMS together with the Chairpersons of Technical Committees should brisk up the work on the carrying out of comparisons of national measurement standards of COOMET Member Countries.

RESOLUTION 19

To ask the Chairperson of JCMS Dr S. Korostin to correct “The Regulations on the Comparisons of Measurement Standards of COOMET NMIs” (COOMET Recommendation R/GM/11:2006) allowing for procedures for excluding comparisons from the Programme of Comparisons of COOMET NMIs and the KCDB in case the work on the comparisons has been stopped groundlessly. The corrected Recommendation should be submitted for the 13th COOMET President’s Council and for further approval at the 19th COOMET Committee meeting.

RESOLUTION 20

To pay the attention of the Chairpersons of Technical Committees and Coordinators of COOMET comparisons to the need to

- meet the deadlines for registering COOMET comparisons in the *Appendix B* of the KCDB;
- notify the KCDB Administrator about the changes in the stage of comparisons in proper time;
- prepare comparison reports for publication in the KCDB in proper time.

RESOLUTION 21

The COOMET Website Administrator Dr V. Bugayev and Chairperson of JCMS Dr S. Korostin should continue the development of the automated database on COOMET comparisons in 2008. The results of this work should be reported at the 13th COOMET President’s Council and 19th COOMET Committee Meeting.

6.6 Results of developing and approving the electronic version of the COOMET Calibration Certificate

RESOLUTION 22

To approve the results of the development of the programme for drawing up the COOMET Calibration Certificate.

To charge COOMET Secretariat to send the programme to the Committee Members for approbation and application.

6.7 Results of discussing the Draft Document *Rules for Carrying Out the Programme of Calibrations of Measurement Standards of COOMET NMIs*

RESOLUTION 23

Taking into account the results of the discussion to consider it unpractical to continue the development of the document “Rules for Maintaining the Programme of Calibrations of Measurement Standards of COOMET Member Countries” and formation of the Programme of Calibrations of Measurement Standards of COOMET NMIs.

To ask the Coordinators of Project 383/UA/07 Dr P. Neyezhnikov and Dr S. Korostin to close the project, draw up the final report and send it to COOMET Secretariat in order to inform COOMET Committee Members in accordance with the COOMET Rules of Procedure.

7 Submittal of COOMET publications developed and updated in 2007–2008 for approval

The Head of the COOMET Secretariat Dr P. Neyezhnikov submitted the updated versions of the COOMET Documents D3, D9, and D5.16, and COOMET Recommendations R/RM/4 and R/AQ/13 registered before, as well as drafts of new recommendations developed by the structural bodies of COOMET.

RESOLUTION 24
