#### **OUTCOMES OF THE MEETING**

### 1. The new COOMET member. Signing the COOMET Memorandum of Understanding by the Republic of Tajikistan

COOMET President Goryslav Sydorenko informed the participants of the meeting that on 10 July 2009 a letter had been received from Deputy Director of the Agency for Standardization, Metrology, Certification and Trade Inspection of the Government of the Republic of Tajikistan (Tajikstandart) Bakhtiyor Shukurov with a request to consider Tajikistan's joining the Euro-Asian Cooperation of National Metrology Institutions (COOMET) as a full member.

An electronic voting was conducted among COOMET Committee Members with regard to accepting Tajikistan in COOMET as a full member. COOMET Secretariat received no objections.

During the meeting a COOMET Memorandum of Understanding was signed by the representative of Tajikistan in a solemn atmosphere.

#### Action:

• To ask COOMET President G. Sydorenko to bring up the approval of the Agency for Standardization, Metrology, Certification and Trade Inspection of the Government of the Republic of Tajikistan (Tajikstandart) as a full COOMET member at the 20<sup>th</sup> meeting of COOMET Committee.

# 2. Implementation of the resolutions of the 13<sup>th</sup> meeting of the President's Council

Head of COOMET Secretariat P. Neyezhmakov reported about the implementation of the decisions of the 13<sup>th</sup> meeting of COOMET President's Council.

Actions:

- To ask Quality Forum TC member from Russia N. Muravskaya to send an application letter to the Chairperson of COOMET Quality Forum S. Musil with a request to carry out a peer review of the QMS of VNIIR, Russia, prior to July 2010;
- To ask COOMET Secretariat P. Neyezhmakov and Chairperson of JCMS S. Korostin to open, prior to 15 January 2010, a COOMET project to study the needs of scientific keepers from NMIs of COOMET member countries in training, define the form and subjects of the training.

### 3. Distribution of responsibilities between COOMET vice-presidents taking into account the new structural body (TC 5)

COOMET President G. Sydorenko and COOMET Vice-Presidents discussed possible changes in the distribution of responsibilities among the Vice-Presidents taking into account the new structural body (TC 5 "Common Research in Metrology").

COOMET Vice-President K.-D. Sommer kindly agreed to coordinate the activities of TC 5 and include the coordination of common research projects (TC 5) into his terms of reference as a COOMET Vice-president, particularly:

Sommer and disseminate this document to COOMET Vice-Presidents for approval prior to 15 January 2010;
- To charge COOMET Secretariat to include the approval of the new Distribution of Responsibilities among COOMET President and Vice-Presidents into the agenda of the 20th meeting of COOMET Committee.

### 4. Results of the 23<sup>rd</sup> meeting of JCRB

The Representative of COOMET Vice-President S. Komissarov and Chairperson of JCMS S. Korostin informed about the results of the 23<sup>rd</sup> meeting of JCRB.

• To approve of the activity within SC 4.5 of TC 4 on training the quality managers of the NMIs from the countries of the Central Asia and the Caucasus.

#### 15.3 Cooperation within COOMET Project No. 404/RU-a/07

Representative of COOMET Vice-President S. Komissarov informed about the activities within COOMET Project 404/RU-a/07, as well as presented a draft Recommendation "Procedure for forming, reviewing and publishing at the COOMET website

the Calibration and Measurement Services (CMS) of metrology laboratories (centres) of partner countries".

Representative of the National COOMET Secretariat in Germany A. Kögler expressed her opinion on the form of submitting these data to the COOMET website.

The order of submitting information and carrying out CMS reviews was discussed.

#### Actions:

• To charge COOMET Secretariat to distribute the Draft Recommendation "Procedure for forming, reviewing and publishing at the COOMET website the Calibration and Measurement Services (CMS) of metrology laboratories (centres) of partner countries" among TC 4 members for discussion.

### 15.4 Changes of the deadlines for submitting annual reports of the chairpersons of COOMET structural bodies

Head of COOMET Secretariat P. Neyezhmakov presented the changes to the COOMET Rules of Procedure relating to the deadlines for submitting annual reports.

The participants of the meeting exchanged their opinions in this regard.

Decision and action:

- To approve of the proposed changes;
- To charge COOMET Secretariat to bring up the approval of the changes to the COOMET Rules of Procedure at the 20<sup>th</sup> meeting of COOMET Committee.

#### 15.5 Nominees for the title "Honorary Metrologist of COOMET"

COOMET President G. Sydorenko presented two nominees from Russia and Ukraine for awarding the title of "Honorary Metrologist of COOMET".

COOMET Vice-President K.-D. Sommer said that changes should be introduced to COOMET Document D7/2005 "Statement on the honorary title "Honorary Metrologist of COOMET" relating to the order of conferring the Honorary Title to the members of COOMET President's Council.

COOMET Vice-President N. Zhagora proposed discussing this issue at the 20<sup>th</sup> meeting of COOMET Committee.

During the discussion of the issue Head of COOMET Secretariat P. Neyezhmakov asked to withdraw his nominee for ethical reasons.

COOMET Vice-President K.-D. Sommer noted the high professional level of the Head of COOMET Secretariat P. Neyezhmakov and his personal contribution into the development and improvement of COOMET activity.

Decision and actions:

• To take note of the information about the nominees from Russia and Ukraine;

- To charge COOMET Secretariat to send letters to the rest of the COOMET Committee Members with a request to name, prior to 1 March 2010, the candidates (not more than one per country) to be awarded the Honorary Title "Honorary Metrologist of COOMET";
- To charge COOMET Secretariat to organize discussion among the members of COOMET President's Council of the proposed nominees prior to 20 march 2010;
- To charge COOMET Secretariat to include the awarding of the Honorary Title "Honorary Metrologist of COOMET" into the agenda of the 20<sup>th</sup> meeting of COOMET Committee.

#### **15.6 COOMET flag**

COOMET President G. Sydorenko and Head of COOMET Secretariat P. Neyezhmakov presented a material COOMET flag sample.

Decision and action:

- To accept the sample on the blue background as the official COOMET flag;
- To ask COOMET President to organize the production of a COOMET flag for each COOMET member country by the 20<sup>th</sup> meeting of COOMET Committee.

COOMET Vice-President N. Zhagora kindly proposed to hold the 15<sup>th</sup> meeting of COOMET President's Council in Belarus in November 2010.

Action:
