

WELCOMING SPEECH FROM THE ORGANIZERS OF THE MEETING

Chairperson of the Committee for Technical Regulation and Metrology of the Ministry of Industry and Trade of the Republic of Kazakhstan Gabit Mukhambetov welcomed the participants of the meeting. RESULTS OF THE MEETING

1 ENTRY OF THE AGENCY FOR STANDARDIZATION, METROLOGY, CERTIFICATION AND TRADE INSPECTION OF THE GOVERNMENT OF THE REPUBLIC OF TAJIKISTAN (TAJIKSTANDART) INTO COOMET

COOMET Vice-President N. Zhagora informed the participants of the meeting that on 10 July 2009 COOMET Secretariat had received a letter from Deputy Director of the Agency for Standardization, Metrology, Certification and Trade Inspection of the Government of the Republic of Tajikistan (Tajikstandart) Bakhtiyer Shukurov with an application to join the Euro-Asian Cooperation of Regional Metrological Institutions (COOMET) as full COOMET member.

An electronic voting was made among the COOMET Committee members. COOMET Secretariat received no objections.

During the meeting Tajikstandart was admitted to COOMET as full member.

Deputy Director of Tajikstandart Bakhtiyer Shukurov was nominated for the COOMET Committee member from Tajikistan.

2 IMPLEMENTATION OF THE DECISIONS OF THE 19TH COOMET COMMITTEE MEETING. PRESENTATION OF THE MINUTES

Head of COOMET Secretariat P. Neyezhmakov presented the Minutes of the 19th OOOMET Committee meeting and informed that the final version of the Minutes took into account all proposals and comments received by Secretariat.

3 COOMET PRESIDENT'S REPORT

COOMET Vice-President N. Zhagora presented the COOMET President's report on "COOMET activity after the 18th meeting of COOMET Committee (May 2009 – April 2010) and tasks of cooperation". The report described the results of activities in 2009–2010. The main tasks of COOMET for the near future were emphasized.

4 IMPROVEMENT AND FURTHER DEVELOPMENT OF COOMET ACTIVITIES

4.1 Approval of allocation of responsibilities and authorities of Vice-Presidents of COOMET

COOMET Vice-President N. Zhagora presented the revised version of allocation of responsibilities and authorities among COOMET Vice-Presidents in view of the establishment of a new field of cooperation and a new structural body of COOMET (TC 5 "Joint Research in Metrology").

4.2 Changes in the COOMET structure (TC 2 "Legal Metrology")

Since TC 2 Chairperson could not participate in the meeting COOMET Vice-President in charge of legal metrology spoke within this item. N. Zhagora described the new structure of TC 2 "Legal Metrology" proposed by the TC 2 members during the 10th TC meeting and approved at the 14th meeting of COOMET President's Council.

The participants of the meeting approved the new structure of TC 2 "Legal Metrology".

4.3 Fields of activities in TC 5 "Joint Research in Metrology"

Head of COOMET Secretariat P. Neyezhmakov presented the information of COOMET Vice-President K.-D. Sommer on the progress in developing the regulations on TC 5 "Joint Research in Metrology".

4.4 Changes in COOMET Rules of Procedure

To facilitate the formation of the COOMET Project Database and taking into account the actual generalized fields of cooperation Head of COOMET Secretariat P. Neyezhmakov proposed the changes to the COOMET Rules of Procedure relating to the changes in the classification of COOMET projects.

4.5 Development of COOMET web-portal

COOMET Website Administrator V. Bugayev and Head of COOMET Secretariat P. Neyezhmakov spoke within this item.

V. Bugayev described the basic development principles and technical requirements to the working COOMET web-portal the main task of which is to create a document-handling system of the organization. The overall concept of developing the working COOMET portal as well as the required components and basic technical requirements assuring its functionality were discussed.

P. Neyezhmakov made a presentation with the development results and the principle of operation of the new COOMET web-portal.

P. Neyezhmakov also informed on the results of the training workshop for on-line editors of the new COOMET web-portal held on 18–23 March 2010 in PTB, Braunschweig, Germany.

4.6 Cooperation within COOMET Project 404/RU-a/07

Coordinator of 404/RU-a/07 V. Bugayev informed on the progress within this project and submitted COOMET Recommendation "Procedure for Forming, Reviewing and Publishing Calibration and Measurement Services of Metrology Laboratories (Centres) of Partner Countries on the COOMET Website" for consideration.

4.7 Establishment of an expert group on kinds of measurements

The Chairperson of the COOMET Joint Committee for Measurement Standards S. Korostin informed on the progress in determining the members of measurement-specific technical expert groups CMC review.

5 MAIN RESULTS OF COOMET ACTIVITIES IN 2009–2010

5.1 Annual report of COOMET Secretariat

Head of COOMET Secretariat P. Neyezhmakov gave an annual report of the activity of COOMET in 2009–2010.

5.2 Annual reports of the Chairpersons of the Structural Bodies

Chairperson of the COOMET Joint Committee for Measurement Standards S. Korostin presented the report with an overview of the activities of COOMET Technical Committees 1.1-1.12 in 2009–2010, as well as information on the results of the Joint Committee meeting held on 20 April 2010 during which the detailed annual reports of the Chairpersons of TCs 1.1-1.12 were made.

The report of the Chairperson of the COOMET Joint Committee was supplemented with the information from the Chairpersons (or their representatives) of COOMET Technical Committees who participated in the meeting.

COOMET Vice-President N. Zhagora read out the annual report of TC 2 and spoke in detail about the projects being implemented in this field, results of the last TC 2 meeting (September 2009, Lithuania).

Secretary of the COOMET Quality Forum and TC 3.1 E. Kromkova informed on the resultsof activities of the Quality Forum in the field of quality management system (QMS) evaluation of the NMIs of COOMET member countries performed for the implementation of CIPM MRA. The problem of carrying out peer reviews of QMS of NMIs from COOMET member countries located at a considerable distance.

Chairperson of TC 4 "Information and Training" P. Neyezhmakov presented the annual report on COOMET activity in the field of information and training and the results of the TC4 Work Program for 2008–2010.

5.3 Information on the completion of work on the revision of COOMET publications on CRM

Deputy Chairperson of TC 1.12 "Certified Reference Materials" I. Dobrovinskiy informed on the finalization of activities on revising COOMET publications on certified reference materials (CRM).

He emphasized that in view of the new activity areas in COOMET relating to the implementation of the CIPM MRA, demonstration of measurement capabilities of NMIs, i.e. CMC, confirmation of these capabilities through comparisons etc., and taking into account the appropriateness to harmonize COOMET documents with ISO/REMCO Guides, the need to revise current COOMET normative documents on CRM had been evaluated in 2006. As a result of this evaluation a program for recommendation revision was approved.

In 2008, at the 18th meeting of COOMET Committee two revised recommendations were approved. Drafts of two other COOMET recommendations were presented for approval at the 20th meeting of COOMET Committee.

The implementation of these activities is a logical end to the revision of the complex of underlying COOMET documents on CRM.

6 IMPLEMENTATION OF THE CIPM MRA

COOMET Vice-Presidents V. Krutikov and N. Zhagora, Head of COOMET Secretariat P. Neyezhmakov, Chairperson of the Joint Committee for Measurement Standards S. Korostin and Secretary of Quality Forum TC 3.1 E. Kromkova reported within this item of the agenda.

6.1 Results of the 23rd and 24th JCRB meetings

COOMET Vice-President V. Krutikov, Chaiperson of the COOMET Joint Committee for Measurement Standards S. Korostin and Head of COOMET Secretariat P. Neyezhmakov informed the participants about the results of the 23rd and 24th meetings JCRB, the main results and problems of the NMIs of COOMET member countries to implement the CIPM MRA, and about the future challenges facing COOMET.

6.2 Implementation of the Program of Comparisons of COOMET

The participants of the meeting discussed the problems of organizing and carrying out comparisons of national measurement standards within COOMET. Chairperson of JCMS S. Korostin presented information on the implementation of the Program of Comparisons of Measurement Standards of COOMET NMIs.

6.3 Current state of work on preparation and review of COOMET CMC

Chairperson of JCMS S. Korostin provided detailed information on the status of preparation and review of COOMET CMC and conducting inter-regional review of CMC of other RMOs

6.4 Carrying out presentations and peer reviews of quality management systems of NMIs of COOMET member countries in 2010-2011

Secretary of COOMET Quality Forum TC 3.1 E. Kromkova provided information on the conducting of peer reviews of QMS in NMIs of COOMET member countries. Attention was drawn to the need to carry out reviews as soon as possible in all NMIs of COOMET member countries which signed the CIPM MRA.

6.5 Results of International Workshop within COOMET "10 Years of the CIPM MRA: Results and Perspectives of Cooperation"

COOMET Vice-President V. Krutikov informed the participants about the results of the International Seminar "10 years of the CIPM MRA: Results and Prospects of Cooperation", held within COOMET on 22 September 2009 in Kazan, Russia.

6.6 Results of the 12th meeting of NMI Directors and symposium, devoted to the 10th anniversary of the CIPM MRA

COOMET Vice-President N. Zhagora told the audience about the results of the 12th meeting of directors of NMIs and the symposium on the 10th anniversary of the CIPM MRA (7 October 2009, Paris, France).

7 RESULTS OF THE 44TH MEETING OF CIML AND COOMET TASKS RESULTING FROM ITS DECISIONS

Representative of the National Secretariat of COOMET in Russia S. Komissarov summarized the results of the 44th meeting of CIML.

Participants discussed the challenges of COOMET and NMIs arising from its decisions.

8 SUBMITTAL OF COOMET PUBLICATIONS DEVELOPED AND UPDATED IN 2009–2010 FOR APPROVAL

Head of COOMET Secretariat P. Neyezhmakov submitted the COOMET publication updated in 2009-2010 for approval.

The participants discussed the viability of changes to COOMET document D7/20____ "Regulations on the Honorary Title "Honorary Metrologist of COOMET".

Deputy Chairperson of TC 1.12 "Certified Reference Materials" I. Dobrovinsky presented to the audience a list of reference materials, agreed on for publication as COOMET CRM, as well as information on the state of COOMET CRM Register.

9 AUTHORITIES OF THE CHAIRPERSONS OF STRUCTURAL BODIES

Head of COOMET Secretariat P. Neyezhmakov informed that in 2010 the authorities of the Chairpersons of the Joint Committee for Measurement Standards S. Korostin, TC 1.4 "Flow measurement" V. Bolshakov, TC 1.11 "Time and Frequency" V. Palchikov, TC 1.12 "Certified Reference Materials" V. Leonov, TC 3.1 "Quality Forum Technical Committee", S. Musil would expire.

The participants extended the authorities of the Chairpersons of JCMS, TC 1.4 and TC 3.1, and the authorities of the Chairpersons of TC 1.11 and TC 1.12 were prolonged to the next meeting of the corresponding TCs and to the decision-making.

Head of COOMET Secretariat P.
