DECISIONS AND ACTIONS of 21st meeting of COOMET Presidential Council

1. The COOMET's 25 -year anniversary

Decisions and actions:

- to note the information presented by the COOMET President regarding COOMET's anniversary;
- to support the proposal on the possibility of holding a seminar dedicated to the COOMET's 25 -year anniversary.

2. Implementation of the decisions of the 20th meeting of Presidential Council *Decisions and actions:*

• to note the information presented by the Head of COOMET Secretariat S. Komissarov regarding the implementation of the decisions of the 20th meeting of Presidential Council.

3. COOMET Development program for 2017-2019

Decisions and actions:

- to note the information presented by COOMET President V.Krutikov on the project of COOMET Development program as the basis of cooperation for 2017-2019
- to instruct COOMET Secretariat to forward the Development program for 2017-2019 to COOMET members till the 20th of November, 2016 for amendments aiming at further approval on the 27th COOMET meeting;
- to instruct COOMET Secretariat to sum up the received suggestions and remarks, and to present the Development program for 2017-2019 for approval on the 27th COOMET meeting.

4. The results of the 35th and 36th JCRB meetings

Decisions and actions:

- to the Chairman of JCRB and the Chairman of TC 1.1 1.12 COOMET pay attention to unreasonably large loss of rights during the interregional examination of CMCs of other RMOs and to take measures to eliminate these problems in future;
- Pay attention of Chairmen of TC 1.1 1.12 COOMET to the fulfillment of the requirement formulated in Document CIPMMRA-D-04 on submission of the confirmation that the quality management system approves CMCs set at the beginning of the interregional examination.

Decisions and actions:

6. The results of cooperation with NCSL International and EURAMET

Decisions and actions:

- to instruct COOMET Secretariat to invite EURAMET President to the 27th COOMET Meeting for discussing the possibility of signing the Memorandum of cooperation between COOMET and EURAMET.

7. Cooperation with the Eurasian Economic Union (the EAEU)

Decisions and actions:

- to instruct COOMET Vice-President V. Gurevich to emend the draft of the Memorandum of Understanding in the area of measurement uniformity between the Eurasian Economic Union and the Euro-Asian Cooperation of National Metrological Institutions considering the completed discussion and send it to the members of the COOMET Committee for approval prior to December 20, 2016 aiming at further forwarding it to the Eurasian Economic Commission;
- to instruct COOMET Vice-President V. Gurevich to organize the meeting discussion between COOMET and the Eurasian Economic Commission concerning the refined version of the draft Memorandum in January-February, 2017, to inform COOMET President and COOMET Committee members about the results;
- to instruct COOMET Secretariat to settle date and venue of signature of the Memorandum of Understanding in the area of measurement uniformity between the EAEU and the COOMET.

8. The work performed on developing normative documents in the field of measurement uniformity assurance in the frames of the EASC and the EAEU

Decisions and actions:
